The Florida Department of Transportation (FDOT) is updating the Florida Transportation Plan (FTP) and the Strategic Intermodal System (SIS) Policy Plan. The FTP defines Florida's future transportation vision and identifies goals, objectives, and strategies to accomplish that vision. The FTP is the statewide long-range transportation plan for all of Florida. The SIS Policy Plan identifies policies for planning and implementing Florida's Strategic Intermodal System, the statewide high-priority network of transportation facilities critical to Florida's economic competitiveness.

Recent News

To guide the update process of the FTP and SIS Plan, FDOT has assembled a Steering Committee. The Steering Committee will provide recommendations to FDOT about the FTP and SIS Policy Plan based on the Committee members' expertise; input from other statewide, regional, and local partners; and supporting technical analysis. New Regulations

October 1, 2015 - EPA strengthened ozone standard

2015 ozone standard - 70 parts per billion (ppb)

2008 ozone standard – 75 parts per billion

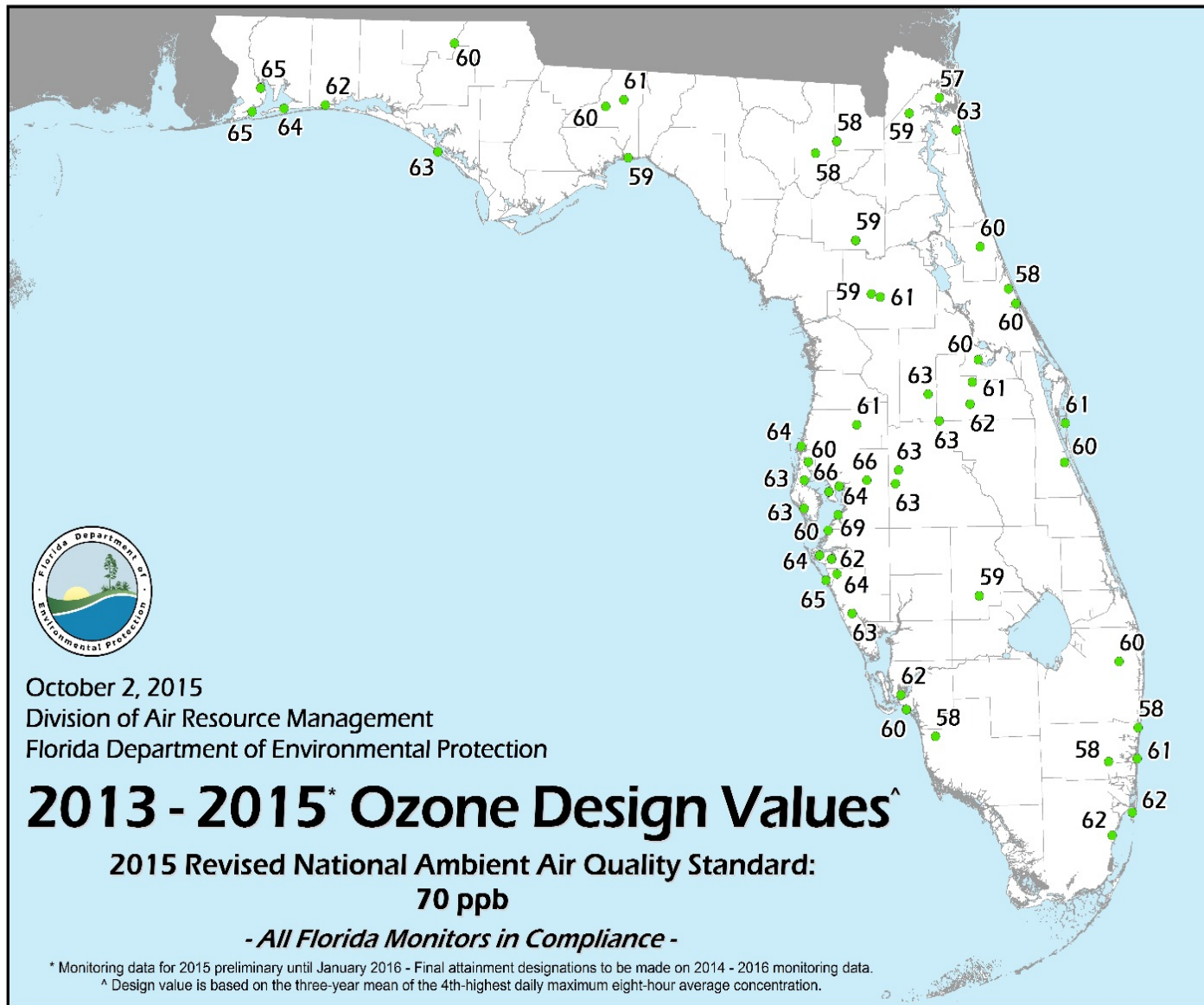
Timeline

States make recommendations to EPA for nonattainment areas based on data from the years 2014-2016.

Designations based on 4th highest annual reading of each monitor in a Metropolitan Statistical Area from 2014-2016.

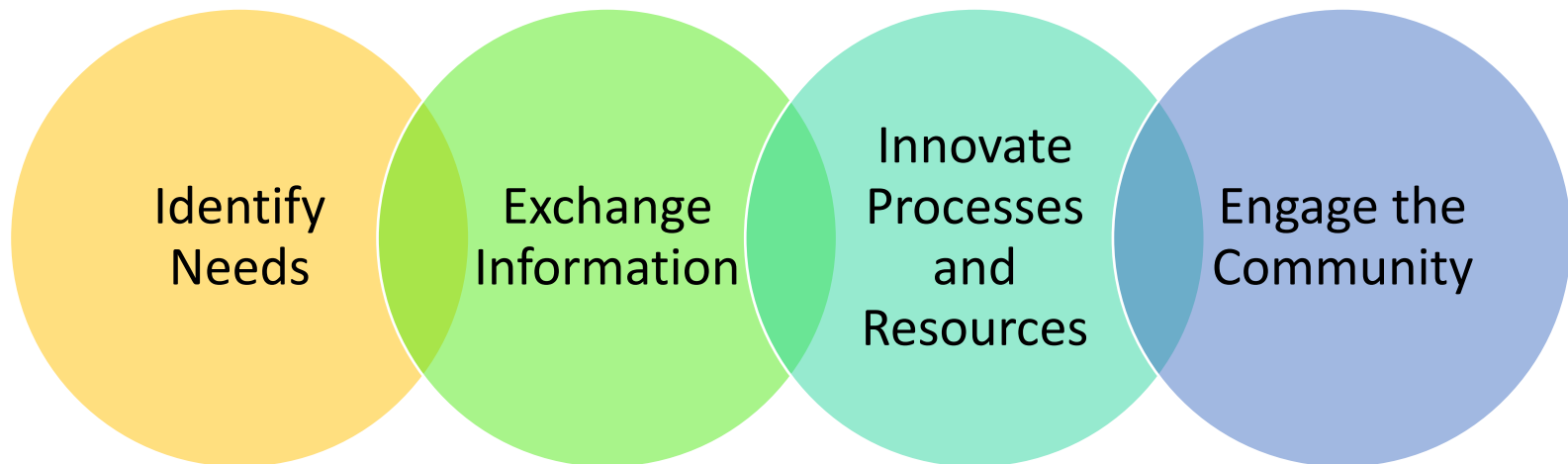
EPA will make final designations by October 2017.

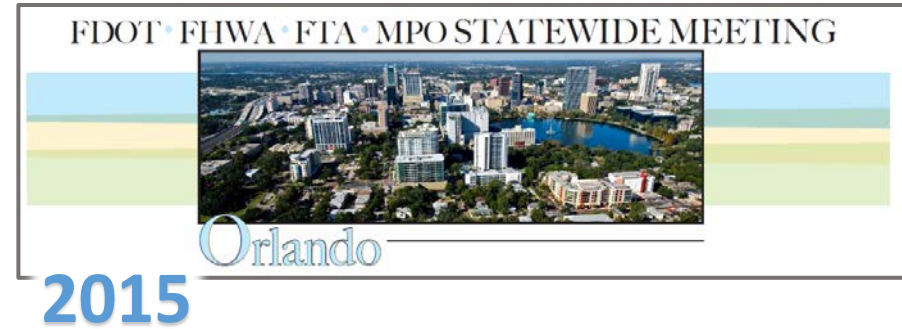

New MPO Agreement & Invoicing Process

The Office of Policy Planning and the Office of Comptroller are working to update the process by which FDOT passes funds to the MPOs.

Why?

- 2 CFR §200 compliance
- Florida Statute & State DFS policy compliance
- Prompt payment & reduction in invoicing submittal requirements

What is changing?

- **New 2-year “MPO Agreement”**
- UPWP requirements
- New invoicing & monitoring processes
